**Subject:** Students registration for National Academic Depository (NAD)

The Government of India is committed towards bringing administrative and academic reforms through the use of technology for delivery of efficient services to all stakeholders. Government has established and officially launched a Digital Depository of Academic Awards known as National Academic Depository (NAD) on the pattern of Securities Depository on July 9, 2017.

By maintaining academic awards in a digital depository NAD aims to bring in a wide range of benefits to Academic Institutions (AI), Students and Employers/Verifiers in the form of enhanced transparency, reduction in costs, better service standards, enabling online access, facilitate validation and retrieval and above all, mitigate reputation risk by eliminating fake/forged certificates.

In accordance with these initiatives of Government of India, MSBTE had decided to keep academic records of students on NAD. For facilitating digitization and its use at student and verifier level, it is mandatory for every student to register on NAD and get NAD-ID.

Links to register on NAD is given below.

**Student Registration** : Student registration can be done

**With Aadhaar** - Student registration with Aadhaar is possible only if Mobile Number or Email address is mapped with Aadhaar database.

After successful registration student gets the NAD-ID. Student should submit this NAD-ID along with mobile number and Email-ID to their respective institute. It will be the responsibility of the institute to submit the same to MSBTE through the link provided for uploading students NAD-ID, in institute login. student registration procedure and fill NAD-ID, mobile number and Email-id given by student in the link "**Upload Students NAD-ID**" available in institute login on or before **10 October 2018**.
